# **Board Membership:**

• Board members were asked to sign the annual "conflict of interest" forms. These were developed in order to comply with our Article XVI from the Bylaws, which states:

#### ARTICLE XVI: COMPENSATION

Section I: Club members will not receive compensation for services performed at a club function or work performed as a result of any committee activity.

Section II: Club members are prohibited from capitalizing on club sponsored functions for personal profit unless approved by The Board of Directors.

This "Conflict of Interest" policy protects against the potential or perception of someone or their family benefitting from decisions around Club activities. The Policy was drafted from online resources for Board of Directors and Officers, especially those who may have an equine related business, solely to cover us as a non-profit in the event of scrutiny.
